



AP® U.S. History Redesign: Announced Textbook Publisher Plans

November 2013

A number of textbook publishers have made plans to release specific materials and publications that will assist teachers and districts in transitioning to the redesigned AP® U.S. History Course in fall 2014. The following information, provided by publishers to the College Board as of November 2013, will be updated on a rolling basis as new information becomes available. Teachers and district coordinators should contact publisher representatives for additional information about specific resources.

Bedford/St. Martin's

- Henretta et al., *America's History* (8th edition) has been revised to support the redesigned curriculum and exam. An annotated AP Teacher Edition of *America's History* is in development. All student and teacher resources for *America's History* are being revised.
- A standalone AP U.S. History test bank includes nine complete sample tests that align with each period of the redesigned course.
- A teacher roundtable discussion on the redesigned course is being planned.

Cengage

- Correlations of Kennedy, *The American Pageant* (14th and 15th editions) to the redesigned AP U.S. History course and exam will be available in October 2013.
- A variety of teacher support materials for the redesigned course, including test questions and suggested skills activities, will be available in January 2014.
- *Fast Track to a 5*, a preparation book for the redesigned AP U.S. History Exam, will be available in spring 2014.
- The AP edition of Kennedy, *The American Pageant* (16th edition) — adapted to the redesigned course and accompanied by new ancillary materials — will be available in fall 2014.

McGraw-Hill

- A 2014–2015 AP United States History Curriculum Guide and Correlation for Brinkley, *American History* (AP edition, 14th edition) is now available.

- A new multiple-choice and short-answer test bank, aligned with the redesigned exam, will be available in February 2014. The test bank accompanies Brinkley, *American History* (14th edition).
- New practice document-based questions and free-response questions, aligned with the redesigned exam, will be available in spring 2014. These materials accompany Brinkley, *American History* (14th edition).
- A new AP Edition of Brinkley, *American History* (15th edition) will be published in September 2014.
- Four practice exams, aligned with the redesigned exam, will be available in June 2014.

- Fraser, *By the People: A History of the United States* (AP edition), which is aligned with the new curriculum framework, will be available in January 2014 — along with MyHistoryLab online resources, a test prep workbook for AP U.S. History, and other aligned ancillaries for students and teachers.

- Correlations for Foner's *Give Me Liberty* (3rd AP edition) and Tindall/Shi's *America: A Narrative History* (9th edition) to the redesigned AP U.S. History course and exam will be available in January 2014.
- AP U.S. History test banks that include sample prompt-based multiple-choice questions and short-answer and long-essay questions that align with the nine periods of the redesigned course — as well as book-specific multiple-choice questions for Foner's *Give Me Liberty* (3rd AP edition) and Tindall/Shi's *America: A Narrative History* (9th edition) — will be available in August 2014.
